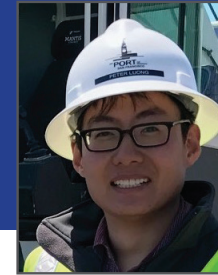
Project Manager/Associate Engineer San Francisco International Airport. For CCSF members, I am asking for your vote for VP San Francisco on the Executive Committee.
