- **Election of Union Officer Election Committee**

[Local 21 Bylaws, Article XIII NOMINATION, ELECTION AND INSTALLATION OF OFFICERS, Section C. Election Committee No. 1: Elections for officers shall be conducted by the Election Committee which shall consist of three (3) regular members in good standing who shall not be candidates for office in the election. The Delegate Assembly shall elect the three members of the Election Committee, in addition to three (3) alternate members, at the Delegate Assembly meeting at which the budget is adopted in the election year. The six (6) members and alternate members of the Election Committee shall be from six (6) separate Chapters.]

[Local 21 Bylaws, Article XIII NOMINATION, ELECTION AND INSTALLATION OF OFFICERS, Section B. Nominations: At least ninety (90) days prior to the date set for elections in each [even-numbered year](#), the Executive Committee shall appoint a regionally diverse Nominating Committee of seven (7) regular members from seven (7) different Chapters...]*

Monday, August 03

- **Notice of Election (Include rules on being a member in good standing and include definition of “regular” membership).**

[Local 21 Bylaws, Article XIII NOMINATION, ELECTION AND INSTALLATION OF OFFICERS, Section D. Election Procedure, No. 1: Notice of the election, including the procedure for nominations, shall be given in writing to each regular member in good standing of the Local Union at least ninety (90) days prior to the date set for the election.]

- **Nominating Committee Present List of Nominees to Election Committee**

[Local 21 Bylaws, Article XIII NOMINATION, ELECTION AND INSTALLATION OF OFFICERS, Section B. Nominations: At least sixty (60) days prior to the election, this committee shall present to the Election Committee a list containing at least one available nominee for each office. The nominees shall be broadly representative of the membership of the Local Union and diverse in ethnicity, race, age, gender, sexual orientation and gender identity...]

Friday, October 02

- **Deadline for Nomination Petitions**

[Local 21 Bylaws, Article XIII NOMINATION, ELECTION AND INSTALLATION OF OFFICERS, Section B. Nominations: ...Additional nominations for officers may be made via petitions signed by no less than twenty (20) regular members in good standing. Such petitions shall be filed with the chair of the Election Committee no later than thirty (30) days prior to the date of the election.]

- **Cutoff for Member Eligibility List**

[Local 21 Bylaws, Article XIII NOMINATION, ELECTION AND INSTALLATION OF OFFICERS, Section D. Election Procedure, No. 3: All officers shall be elected by means of a secret ballot conducted among all regular members who are in good standing on the 30th day prior to the date on which ballots are mailed, and by majority vote of those voting. The ballot shall be sent to the address recorded in the Local Union office as the last known recorded address of the member.]

Richmond will not be eligible to vote. Richmond Executives Chapter will need to complete requirements for chapter status approved by Delegate Assembly, in order to be eligible to vote. This includes dues checkoff and approval of chapter bylaws by Executive Committee.

October 14

- **Deadline for Candidate Statement and Photos**
- **Extended to Friday, October 16 if the 150-word count is exceeded.**
- **Candidates notice to Mayra to inspect Eligible Voter List.**
- **Candidates may submit a one-page post ready flyer (8 ½” x 11”) in pdf format to Election Committee. (The flyer cannot be exchanged once it has been posted on the website.)**

October 23

- **Deadline for one-page post ready flyer (8 ½” x 11”) in pdf format to Election Committee.**

October 19-22

- **Inspection of Eligible Voter List**

Monday, November 2

- **Date of Election (Ballots Mailed)**

[Local 21 Bylaws, Article XIII NOMINATION, ELECTION AND INSTALLATION OF OFFICERS, Section D. Election Procedure, No. 2: The date for the conduct of the election shall be the date on which ballots are mailed to members and shall be set by the Delegate Assembly of the Local Union for a day during the first two weeks of November.]

November 16

- **Notice of Observer to Elections Committee**

- **Deadline for Ballots**

[Local 21 Bylaws, Article XIII NOMINATION, ELECTION AND INSTALLATION OF OFFICERS, Section D. Election Procedure, No. 4: For mail ballots, only those ballots returned to the Election Committee within twenty-one (21) days from the mailing of the ballots shall be considered to have been validly cast and shall be counted...]

November 24

- **Vote Count** (Election Committee will conduct vote count).
